**8.** This step is a 2-part process (for Equity and for KRA) where you need to enter the E-authenticate your document through the platform provided by Protean eGov Technologies.

In the first part, Meon Technologies Private Limited (the software provider) will ask you to digitally sign the document for **Equity Account Opening Firm.** 

Agree to the terms (shown by the blue arrow) and enter your Aadhar Card/VID number (shown by the black arrow) and authenticate via the OTP on your registered Mobile Number/E-mail. The process is as shown below:



Repeat the same for KRA E-sign, which is the final step in completing your RE-KYC journey.
